I promise to be solely responsible for this animal, and to indemnify and hold harmless Paws-N-Claws Rescue from any and all claims and liability for the conduct of this animal on or after the date of this adoption. This Release of Liability and Indemnification shall apply to all known, unknown and unanticipated damages resulting from my adoption, ownership or control of such animal.

Given the number of animals we assist, if this animal is returned to Paws-N-Claws Rescue the adoption fee is non-refundable.

I agree not to sell, trade or dispose of this animal or to relinquish it to any party other than Paws-N-Claws Rescue. I agree that if I can no longer keep this animal, I will return it to Paws-N-Claws Rescue.
